AYES: Cummings, Blevins, Neal, Wilmoth, Smithson. NAYS: None. Motion carried

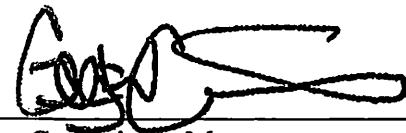
