


# BUCHANAN HEIGHTS ADDITION TO THE TOWN OF CRESCENT, OKLAHOMA.

## CERTIFICATE OF OWNERSHIP & DEDICATION

North of the Southwest corner of the  $SE\frac{1}{4}$  of Sec. 11-T17N-R4W, I.M., Logan County, Oklahoma, thence North a distance of 404.28 ft., thence West a distance of 300 ft., thence South a distance of 404.28 ft., thence East a distance of 300 ft. to the point of beginning; and that David C. Buchanan & Mildred G. Buchanan, husband and wife and Thomas H. Grant are the owners of the following described tract of land, to-wit: Beginning at a point 600 ft.
