

## CERTIFICATE OF OWNERSHIP

Know All Men By These Presents:-  
 That Arthur Davis, W.O. Munkres, C.C. Browning and Elmer Rhodes, being the owners of a tract of land 416 ft. wide which is parallel and adjacent to the A.T.&S.F. Railroad on the East, situated in the S.W. $\frac{1}{4}$  Sec. 11 T.17N. R.4W. I.M. Logan County, Oklahoma, and described by meets and bounds as follows:-  
 Beginning at the Southeast corner of the Southwest quarter (S.W. $\frac{1}{4}$ ) of Section Eleven (11) Township Seventeen North (T.17N.) Range Four West (R.4W.) I.M.; thence North along the East line of said S.W. $\frac{1}{4}$ , a distance of Three Hundred Sixty Three (363) ft.; thence in a Northwesterly direction, parallel to the A.T.&S.F. Railroad, a distance of 466 ft. from the center line thereof, a distance of Three Thousand One Hundred Sixty Three Seven Tenths (3163.7) ft. to the North line of said S.W. $\frac{1}{4}$ ; thence West along the North line of said S.W. $\frac{1}{4}$ , a distance of Four Hundred Ninety Nine and Five Tenths (499.5) ft., to the Northwest corner of said S.W. $\frac{1}{4}$ ; thence South along the West line of the said S.W. $\frac{1}{4}$  a distance of Seventy Three and Three Tenths (73.3) ft. to the Railroad Right-of-Way; thence in a Southeasterly direction along the East side of the Railroad Right-of-Way, a distance of Three Thousand Four Hundred Ninety Three (3493) ft. to the south line of the said S.W. $\frac{1}{4}$ ; thence East along the said South line of said S.W. $\frac{1}{4}$  a distance of Two Hundred Sixty Three and Eight tenths (263.8) ft. more or less, to the point of beginning, have caused the same to be subdivided into Blocks, Lots, Streets and Alleys, and that the annexed map or Plat is a correct representation of said land as subdivided, which we hereby designate and name "Stobaugh Addition" and dedicate the Streets and Alleys as shown on said map or plat, to the public.



